### President's Message

With another election behind us, I can't help but reflect on how much progress our League has made in our community. We have gained a lot of visibility during the past three years. We received many requests for ballot measure presentations and candidate forum moderators. (See the following article on November 2010 Election Activities.) In addition, we received many phone calls ranging from requests for voter information to whom to call to get political signs for their yard. It is gratifying to know that people view the League of Women Voters as a source of information – especially during elections.

This was a very busy election, and the turnout was great. Throughout California, the turnout was 59.5% of registered voters. But within Placer County, the turnout was 72% - one of the highest in the state, especially for a county of our size. Despite the fact that 57% of registered voters are signed up for vote by mail, the polls were busy all day. That includes a large number of vote-by-mail voters who dropped off their ballots at the polling precincts.

During every election, I am also amazed at the thorough organization of our Elections Department. Jim McCauley, Placer County Clerk, Recorder and Registrar of Voters, and his wonderful team do an incredible job of organizing the myriad details required to make the elections run smoothly. I had the pleasure of learning about all the planning and preparation required just to make each polling place

accessible for the disabled and have a new appreciation for the amount of work required before each election. The Elections Department staff just completed wrapping up the November election and now has to quickly gear up for the special election in January. We even moderated a special pros and cons presentation in Truckee for Proposition 19, the controversial measure to legalize marijuana. We distributed over 700 Easy Voter Guides throughout the county during this election, and actually could have used more to distribute to local libraries.
